User agrees to use the material received under this agreement (the "Data") only for information retrieval, computer vision, or pattern recognition research and technology development. User agrees that the Data may only be used for research purposes, and that the material is prohibited from use in commercial advertising of any kind. User agrees not to disclose, copy or redistribute the material to others outside of the User's research group and/or the User's consortium of independent, collaborating research groups.

Where the User represents a consortium of independent, collaborating research groups, the User will, in addition to submitting this form to NIST on behalf of the User's consortium, be responsible to:

1. Collect a signed NIST TRECVID 2008 Event Detection Evaluation Agreement from each group within in the User's consortium before submitting this form.
2. Maintain the signed forms and provide a copy of the forms and a list of all groups in the User's consortium to NIST upon request.
